## **Business:**

- 1. The Board reviewed the agenda for tonight's meeting.
- 2. The Board reviewed the minutes from the Board meeting on December 18, 2019.
  - a. Jon moved to wait to approve the minutes once there is a quorum of board members present who were present at the December 18 meeting; Allen seconded the motion.

    Motion passed unanimously.
- 3. Fire Chief's Report
  - a. The Survivors of Sudden Cardiac Arrest breakfast is Thursday February 20 at 8:30am at the Main Fire Station. The annual event is hosted by the Fire and Police Departments to honor the lives saved from cardiac events. All board members are invited to attend.
  - b. Tualatin Valley Fire & Rescue (TVF&R) Station 39 officially opened Tuesday, January 21, 2020. The new station is located at 7080 SW McEwan Road. The station has 2 people on each 24-hour shift.
    - i. Sherry moved to pick up a "Welcome to the Neighborhood" gift card valued at \$25.00 from Too Sweet Cakes for each of the 3 shifts at TVF&R Station 39; Jon seconded the motion. **Motion passed unanimously.**
    - ii. Allen moved to pick up a "Thank You" gift card valued at \$ 40.00 from Too Sweet Cakes for each of the 3 shifts at Lake Oswego Station 211 at the corner of Bryant and Jean Roads; Jon seconded the motion. Motion passed unanimously. The Board would like to do a "Thank You" gift to each of the 4 stations annually.
  - c. Monday February 3, Sherry, Allen and Michelle will tour the police station and the Lake Oswego Communications Center (LOCOM) 911 Dispatch Center.
